

100 % SOLIDS EPOXY (CRACK FILL)

Description:

100% Epoxy is a two component Epoxy material designed for maximum adhesion and hardness for use in filling cracks in concrete. Chase the crack with a diamond concrete blade, clean area with power washer, let dry, mix equal parts Epoxy A & B, let stand 15 minutes mix again, pour into crack. Fill crack equal to concrete surface. While Epoxy is still wet, dust surface with 30 silica to enhance adhesion of any and all topcoats. Without this sand adhesion enhancer, the surface is too hard for products to adhere to. Let dry, scrape hard surface and topcoat. Note: product will be dry hard in 3 hours max. Unused material in the can will reach temperatures over 150 F. Use caution when handling. **Benefits:**

Mixing Instructions:

RATIO: 1 parts of A to 1 part of B.

Mix part A with part B well **LET MIXED COATING STAND FOR 10 MINUTES** (this is the induction time). After the 10 minute induction time, mix again. Epoxy is now ready to fill cracks.

Dry Time:

Set to Touch: 30 min to 1 hour, depending on temperature and humidity

Total Dry: 1 to 3 hours.

Adhesion:

Adhesion testing is applied at 1.0 dry mils and air dried 7 days
